## **TREASURER/ARCHITECTURE**

Cash balances are up \$270,000 over last year due almost entirely to our hold back of sewer charges from Braidwood. Hopefully the new city administration will put our dispute on the front burner and get a resolution.

With the current run of bank closures nationally, you can feel comfortable that we have limited our deposits in any one bank to the FDIC insured maximum of \$250,000 which means we now have accounts at 6 area banks. Dues collected in the 1st quarter of this year, but not needed until later in the year, are in CDs earning around 4% interest.

Income and expenses through April are showing an increase in revenues over budgeted amount of \$40,000 due primarily to a \$20,000 untouched snow removal budget and under budget sewer and water payments.

## **SAFETY/CODE ENFORCEMENT**

### Greetings,

With summer months fast approaching, I would like to share some important facts to our member and guests. 1.Gate Violations—No person is allowed for any reason to:

A. Lift or otherwise tamper with the operation of a gate arm

B. Drive around a gate arm

C, Drive under a gate arm behind another vehicle (tailgate)

D. Drive through any opening not for a motor vehicle

E. Anyone purposely breaking gate arm will be fined

2. Golf Carts-Please follow all "Rules of road"

A. Must display members' lot numbers in contrasting color on each side. Lot numbers shall be visible at all times and be at least 2" high.

B. Must display current annual decal on each side. This year they are brown 23-24.

C. Golf carts must be electric only. No gas carts are allowed

D. No other types of battery powered vehicles are allowed to be driven on any roadways or common areas including nature trail

E. If driven after daylight, must have working headlights and lights or reflectors on rear

F. All passengers must be seated in a seat. Only as many passengers as there are seats are allowed on the golf cart. No one may stand up or hang off a cart.

G. No golf cart may pull any persons behind it on any type of recreational equipment, bicycle, wagon, skateboard, etc.

H. Golf carts must be driven in a safe manner at all times and obey the Illinois "Rules of Road" including one way streets. no parking signs and stopping at all stop signs.

I. Golf carts may be driven only on roads, the nature trail. Please use caution as some turns and downward hills is where your eye site may be obstructed and increased speed may add danger to others using the trail

Annual decals must be displayed by July 1st of each year. Same rules apply for all watercraft. A certificate for bodily injury liability of no less than 100,000/300,000 per person per accident must be on file by July 1st of each year. For more information, please refer to "Property Owners Guidebook."

3. **Fishing**—Fishing is permitted in all of the lakes on the property with the exception of the REARING POND. Size and quantity limits are posted throughout the property. Members are responsible for their guest (s) as well as themselves and should make sure that anyone fishing knows the regulations and is respectful of the rules and other members' property.

Members are responsible for their guest as well as themselves and should make sure that anyone fishing knows the regulations and is respectful of the rules and other members' property.

When a member invites guests or relatives to fish in our lakes:

A. A member must be present with them or at members' lot.

B. The member must give them written permission if the member is not going to be present at his lot

C. The member may allow his contractor to fish only from his lot and the member is present.

D. Fishing Club recommended fish limits must be followed and the State of Illinois limits must not be exceeded.

E. No fishing is allowed from any bridge.

F. No fishing is allowed at beach area.

G. Unattended fishing lines may be not left in the water.

## **POOL RULES / SHADOW LAKES II ASSOCIATION**

- 1. All swimmers have to take a shower before entering the pool area.
- 2. All children not potty trained MUST wear tight fitted swim diapers.
- 3. Clear water bottles will be allowed in the pool area. All coolers and/or food containers will need to be left in the Amenity Center.
- 4. NO gum allowed in the pool.
- 5. ONLY inflatable balls allowed in pool.
- 6. Inflatable tubes can be used at the discretion of the pool monitor. Noodles can be used at anytime.
- 7. All persons with long hair will need ponytail holder. If you forgot one, there will be some in the monitor's office for 25 cents each.
- 8. Children 16 or younger WILL NOT be allowed into the pool or the pool area unless there is someone older (17 years or more) in charge.
- 9. No smoking in the pool area.
- 10. NO running, jumping or diving in the pool. THIS IS FOR YOUR SAFETY.
- 11. No alcohol allowed in the pool area or Amenity Center at anytime. Anyone under the influence will be asked to leave.
- 12. Pool area shall not exceed bather load of 155 persons.
- 13. Your personal conduct within the pool area must be such that the safety of yourself and others is not in jeopardy.

PLEASE RESPEC T THE POOL MONITORS—Remember they are only doing their jobs.

## **ARCHITECTURAL GUIDELINES AND BUILDING PERMITS**

Over the last few years Shadow Lakes has experienced a healthy turnover of new members. With that turnover we have seen new homes and park models on formerly empty lots. We have also seen many improvements to properties that already existed in Shadow Lakes. Some of those improvements were as simple as a new coat of paint or stain or as complex as a new room addition or garage. Improvements to an individual property not only improve the value of that property but also the value of surrounding properties and the value of all of Shadow Lakes.

Building and making improvements to your property are governed by our own Architectural Guidelines as well as the building codes of the City of Braidwood. Almost every improvement or repair that you may be planning will require a permit issued by the Association and may also include a permit from the City of Braidwood,

Permits that are required by the City will first require a visit to the Association office to obtain our permit forms and the those of the City. **THE CITY WILL NOT APPROVE A PERMIT UNLESS IT HAS FIRST BEEN APPROVED BY THE ASSOCIATION.** 

The following building or repair projects require permit from the City and are subject to the building codes in force at the time of the project:

$\diamond$	NEW HOMES (STICK BUILT)
$\diamond$	MODULAR HOMES
$\diamond$	PARK MODEL ON FROST PIERS OR SLAB
$\diamond$	ATTACHED GARAGES AND ROOM ADDITIONS
$\diamond$	REPLACEMENT OF MOBILE HOME OR PARK MODEL
$\diamond$	DETACHED GARAGES
$\diamond$	SHEDS AND GAZEBOS
$\diamond$	EXRERIOR WORK (each job requires a separate permit)
$\diamond$	DECKS, DOCKS, PORCHES, CONCRETE PATIO, SIDEWALKS AND CONCRETE DRIVEWAYS
$\diamond$	INTERIOR WORK REMODELING (each job requires a separate permit)
$\diamond$	UPGRADE ELECTRIC OR PLUMBING SERVICES, MOVING WALLS OR ANY STRUCTURAL CHANGES
$\diamond$	FENCES
$\diamond$	RETAINING WALLS
$\diamond$	DEMOLITION PERMIT
$\diamond$	NO-CHARGE PERMITS

In addition to complying with the City's permit requirements, your project must also comply the rules contained in the Association's Architectural Guidelines. Some of our rules are unique to Shadow Lakes so please become familiar with our Guidelines prior to submitting your plans to the Association office. If needed, the Association will help you properly complete your permit forms.

If you are planning or even just thinking of a new project for your property and don't have a current copy of the Architectural Guidelines they are available on our web site and in the office. All new property owners are given a copy in their welcome package.

**A FINAL FRIENDLY WARNING**-Any project not properly permitted by both the Association and the City of Braidwood may be subject to removal of the project and possible fines.

#### Chairman continued.

As you read Don's reminders along with Cassie's listing of pool rules, keep in mind that all of our rules are intended to provide a safe environment for you your family and guests. As you look at the audited statement you will see that in 2021 members paid \$24,771.00 violations and penalties and \$26,992.00 again in 2022. It has been my hope that these amounts would decrease year after year. That would then indicate safe consideration for your neighbors and guests. Remember, you are responsible for the conduct of your guests.

You will soon be receiving your ballot packet for this year's election for one Director. Your vote is important not only for our Association but also for the candidates seeking the directorship. As you make your choices from the slate of candidates, please take care to follow all of the instructions to be certain that your vote for the candidate of your choice is counted. PLEASE VOTE!

Also in this issue, we have provided key information related to city building permits and our own architectural guidelines. Should you have any questions regarding the need for permits or any planned project, please call the office. We will make every effort to help make the permit process easy for you.

We would like to start honoring all of the veterans who own property in Shadow Lakes. If you would like to be included on the Honor Roll, please complete the form on page 6 of this issue and return it to the office. We would like to publish the first Honor Roll in the September issue in advance of November's Veteran's Day remembrance.

The strength of any Association is measured not only in dollars and cents but also, more importantly, in its members. One of the ways to maintain that strength is by being involved in our community. With that in mind I appointed Joe Hudetz and Sue Knuth to a search committee to find a new Association Manager. After a long search, Joe and Sue presented a candidate to the Board. After a review and meeting with the candidate, the Board has unanimously approved the hire of a new Association Manager beginning work on July 17, 2023. We will be presenting the new manager at the June 17, 2023 Board meeting.

Managing our Association and running it each and every day of the year is, like running any business, both simple and complex at the same time. Without the hard work and dedication of employees, both permanent and seasonal, the task would be impossible. They have all worked as a team making the tasks of management so much easier. I cannot thank them enough every day for all they do for all of us. Never miss the opportunity to thank them for all they do to keep Shadow Lakes running.

2023 - 2024

An Annual License sticker must be displayed before July 1st of each year to register each golf cart and boat (any water craft) with the Association. You can purchase at the office at a cost of \$5.00. After July 1st, the cost of the Annual License fee will be increased to \$10.00.

A Certificate of Insurance for Bodily Injury Liability of no less than \$100,000 per person/\$300,000 per accident must be filed with the Association and be current. It should list Shadow Lakes II Association as additional insured. Insurance companies can fax or email

## Here Kitty Kitty

Great news!! It appears our TNR efforts have been working! Since Summer of 2022 we have noticed a significant decrease in the number of feral cats in Shadow Lakes.

Our efforts of TNR include: humanely T -Trapping feral cats, taking them to the vet to get N - Neutered and then R - Releasing them back where they were originally trapped.



Since our inception, we have Trapped, Neutered & Released 18 adult cats, and we have rescued and rehomed 17 Kittens. That is a total of 35 less cats breeding in Shadow Lakes - an anticipated 108 less Kittens born this year.

We resumed trapping briefly. But we were not trapping any new feral cats - which is a GOOD THING!! We will be resuming trapping in the Fall as needed. Please be on the lookout for Kittens and notify us of any sightings. We will scoop them up quickly to find a Loving Furever Home and help control our feral cat population.

Friendly reminder: Shadow Lakes does not allow free roaming pets - pets are to wear required tags at all times and are supposed to be leashed when off your property. SL also does not allow the breeding of pets for commercial purposes. Please spay & neuter your pets to help with population control. Shelters are already full of animals waiting to be adopted.

#### INDEPENDENT AUDITOR'S REPORT

#### Opinion

We have audited the accompanying financial statements of Shadow Lakes II Association (an Illinois Homeowners' Association), which comprise the balance sheet as of December 31, 2022 and 2021, and the related statements of revenue, expenses and changes in members' equity and cash flows for the years then ended, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the financial position of Shadow Lakes II Association as of December 31, 2022 and 2021, and the changes in its members' equity and its cash flows for the years then ended in accordance with accounting principles generally accepted in the United States of America.

#### **Basis for Opinion**

We conducted our audit in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Shadow Lakes II Association and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

#### **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Shadow Lakes II Association's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.
