#### TREASURER'S REPORT

As we look back at last year's operating results, on a cash basis, we exceeded our 2017 budget by \$8,773.95. This shortage was covered by funds from our Reserves.

During the six years that I have served as your Treasurer our total budget was \$5,524,000.00. During that time we have seen the completion of major improvements to our Association grounds and buildings including the acquisition of the developers building and land at the corner of Coal City Road and Rt. 129, the TMV/FC bridge that finally connected all of the Villages along with numerous smaller projects that added to the value of our Association. This was the first year (2017) since I became your Treasurer in 2012 that we have exceeded our budget.

Major capital improvements completed during 2017 included \$74,111.00-road paving, \$13,299.00-new fencing, \$9,090.01-pool decking repair, \$15,402.76-new lift station pumps, \$4,375.00-1.5 gallon low flush toilets in the amenity center, \$43,293.73-robotic automatic pool cleaner, \$3,134.32-heavy duty brush cutter and \$5,000.00-for erosion control on Big Shadow Lake. Other projects included adding sand to our beach and volley ball court, adding additional road mix to our nature trail and new basketball backboards and rims.

Our accounting firm has completed their internal work and is in the process of preparing the final 2017 statements as well as our 2017 tax returns. The entire report will be published in the June Fossil Footprints.

As we begin 2018 we are off to a good start. As of January 31<sup>st</sup> we completed the first month within our budget (February results were not available at the time of publication). However, unlike our past two mild and dry winters, we are experiencing higher costs due to snow plowing and extended sub-freezing temperatures affecting our heating and electrical costs. We have already expended 1/3<sup>rd</sup> of our snow removal budget. Our cash position remains strong and we have already made the budgeted reserve contributions bringing our total reserves up to \$205,588.36.

Looking ahead in 2018 we will be adding \$75,000 to road and other paving projects. We will continue to improve our nature trail, opening other areas for use. A bocce ball court will be added to our Amenity Center offerings and additional pool chairs and shade areas will be added to our pool. It is our intention to have all of these projects completed before Memorial Day.

Managing our budgets over those years has been my primary concern as your Treasurer, ensuring that our Association is receiving the best available products and services for the money spent. In doing so, we have seen the Equity of our Association grow from 1.4 million dollars in 2012 to nearly 1.8 million dollars in 2017.

Our Association remains strong and is getting stronger every year. This is due the support of all of our members, our many dedicated employees and volunteers and the unselfish commitment of some of the finest men and women I have had the honor and privilege to serve with as Directors of our Association.

On a personal note, I want to share with you in the loss of a good friend and colleague Henry "Hank" Genteman. His shoes will be very hard to fill and he will be truly missed. Life at Shadow Lakes won't be quite the same without Hank.

#### **MAINTENANCE**

As you begin your "Spring Cleaning," please be reminded not to flush "disposable" wipes, rags or towels to name few of the items that cause damage to the pumps in our lift stations. As you clean your yards and dispose of items, we ask that you review Association rules regarding waste disposal, especially in the areas of yard waste, electronics and old tires. WE CANNOT ACCEPT ELECTRONICS AND TIRES. (See information below.)

If you or your contractor are doing construction work on your property, you will need to get your own dumpster for removal of construction debris. The "Dumpster in a Bag" is available from home improvement stores for small jobs. Larger dumpsters are available from Waste Management and other vendors. WE CANNOT ACCEPT CONSTRUCTION DEBRIS AT THE COMPACTORS OR MAINTENANCE AREA. As a reminder, all construction projects of at least \$300.00 in value must have an Association plan review and an issued permit from the City of Braidwood.

The new fences have been installed at the entrances to Shadow Lakes and the Association has received many compliments from property owners.

The lake chemical weed control program was tested last year and was a success in the Fisherman Village channel. The test will be continued this year to include more channels this year in an effort to improve the quality of boating and swimming at Shadow Lakes.

\$75,000 has been budgeted again this year for road repaving and patching repair. Our goal is to get this done this spring.

Again, I want to thank our personnel, maintenance staff (Joe, John and Brad) as well as our seasonal staff for the excellent job they do and their dedication to the Shadow Lakes Community. When you see them, please thank them for all they do.



#### SECURITY/ARCHITECTURE

#### **WEED CONTROL**

As the ice melts away and new weed growth is detected, Rollins Aquatics will be seen on our waterways fighting the spring and summer weed attack. Having received the Board's blessing after a successful test in Fisherman's Village in 2017, they will roll out a property wide attack on our most weed choked channels and shorelines. Together we have identified our most negatively affected waterways and we will concentrate only on them this year. Other than Tully Monster Lakes, we will not be treating the large lake shorelines or deep waters. We will however be treating almost every channel on our properties as well as public pier areas including on Hawk Lake. The chemicals used will be the same as were used in Fisherman's Village in 2017 and they had no detrimental effect on fish life or properties on the water. You will be notified of a 24 hour NO SWIM order on the day of application but, other than that, you can pursue all normal water activities the day after application.

WHAT YOU SHOULD NOT DO: Don't apply any chemicals or treatments of your own to the water this year! We need to have a clean test of the whole property in 2018. Rollins backs their work with a 10 million dollar insurance policy and many successful references around the area. We believe the treatment will be successful and your enjoyment of our waters and your home value will increase this year.

#### **QUICK RESPONSE TEAMS**

We have 50-75 homeowners who have volunteered for training to be members of QRTs in the event of a disaster that overwhelms our 911 responders. The POAC in coordination with the Board is dividing Shadow Lakes into response Neighborhoods of 30 adjoining homes. The FEMA training that the QRT volunteers in each of these Neighborhoods receive during a 90 minute program will include: Personal Preparedness Supplies, First 10 minute Actions, Team Meeting Location, 30 Neighborhood Homes Identification (names, contact info, disabled or elderly or children, pets, etc.), Neighborhood Supplies and Talents (chainsaws, fire extinguishers, EMT skills, nurses, child care, etc.). Each volunteer will take home a completed workbook with all the above info to access in the event of an emergency.

Meetings will begin taking place in March on Sunday afternoons. Do you want to be prepared and be part of a QRT with your immediate neighbors?

Please call or email the office if you are and we will include you. We need your name, lot number and contact info. Don't forget--When a disaster hits, the time to prepare has ended.

#### **REMINDERS:**

- As we dig out of a foot of snow, please remember to keep all shoveled snow off streets as they are plowed.
- Property upkeep is a year-round responsibility for all of us.
- Please keep your property maintained to prevent it from becoming unsightly, unsanitary or a health hazard.
- Please obey all signs and the speed limit is still 10 MPH for our safety as well as yours.
- Remember to keep your home and sheds locked. We have had a few incidents in the past few weeks with trespassing.
- Any auto or truck that is not in running condition or properly licensed may NOT be stored on any lot in Shadow Lakes.
- Stay safe....spring is right around the corner.



#### TIER 1 WATER TURN ON PROGRAM

**Weather permitting**, our Maintenance Department will begin turning on water service to over 400 properties according to the following schedule.

Explorer Village April 1 thru 7

Fisherman Village April 8 thru 14

Fossil Cove Village April 15 thru April 21

Tully Monster Village April 22 thru April 28

If you prefer a date that is different from the planned schedule a fee of \$25 will be charged to your account. Additional prorated water charges may also apply.

It will be necessary for someone to be present at your property at the time your water is turned on. If no one is present on the request dated and time slot, your water will not be turned on. This is to ensure that your unit is prepared to accept the water service and no damage occurred during the winter.

If a leak is discovered at the time of turn on, we will immediately turn the water off. It will then be necessary to schedule another turn on appointment after you have made the necessary repairs and provide the Association with proof of those repairs.

It is your responsibility to prepare your unit for water. The Association cannot assume responsibility for damages that may occur to your unit.


## **Shadow Lakes II Association Board of Directors Election**



Six large Muskies and lots of giant Catfish were reported. All very healthy, due to our major forage stocking efforts in recent years. Your Club membership of \$35 for each family residence helps us work with the Association to maintain our lakes and fishery. Stocking approximately \$20,000 worth of fish each year. We estimate close to 20 million fish stocked over 24 years, including game & forage. That is approximately 3 million minnows a year. So, please consider joining the Club to continue these efforts; have fun, meet some great folks and learn how to fish.


