Approval of the April 23, 2022 Minutes: Sue Knuth motioned to approve, Sue Kielnik seconded. Minutes approved.

Gate 3: It will probably be added on next year. Right now, there is somewhat of a fix. Do not go over it too much.

Boil Order and signs for the gates. They will try to post the signs as you enter Shadow Lakes by the card reader instead of on the gate as it goes up.

The City of Braidwood and Shadow Lakes are still in conference with the increase in water costs. Golf Cart Safety: There are a lot of younger people, please tell them that this is not allowed to have young children ride in the laps. Try to positive. No underage drivers, no standing. Driver licenses are required or a permit.

Shers term is up in August. If interested to be Chairman of the POAC send in a letter of intent. There will be a special vote in July.

Ron Wilczak - Update on his gate entry committee

Remote Gate Entry. Identified 4 to 5 vendors, created a spreadsheet to analyze those vendors, have identified what the needs are for the gate entry and will check to see if any of these vendors will be appropriate. There was an incident where remote gate would have been useful by letting a utility work truck in to fix a broken line. A discussion ensued on pros and cons to the remote gate systems. Sher noted that this is a proposal. As soon as all information is gathered it can then be submitted to the Board. A special meeting will be called by the POAC when the committee comes to finishing their research.

Recording of Meetings. We will be getting ready to send the POAC recommendation to the Board to livestream/videotape the meetings. There is Livestream Facebook (no cost), U tube (cost), and Website (cost). Would a topic be on a specified time? The Board would need an administrator that comes from the Board for a specified time. Ron stated that would be up to the Board. A lot of kinks would have to be worked out. There would have to be rules of conduct. Sher noted that information would have to be gathered before sending the request to the Board. Possible "rental" fee to offset costs. Zoom meetings might have interaction with audience. The chatroom would have to be monitored.

Marcia – Common areas permits. Marcia gave her proposal to Wayne Kancler and he is still working on it. If a permit is allowed for large groups and which common ground areas. Designate which the permit would be for: Games, Fishing, picnicking, swimming; the noise would have to be contained. Also it was suggested that the Nature Trail be closed after a certain time at night.

Recycling – More information given on more recyclables.3 different types, latex, paint, electronics and tired which is coming from the Will County Department on Recycling. Information is available on the desk at the front of the meeting.
