Budget – Terry Hintzel Clay pool increase was addressed. This increase will be a minimal charge that will cost about an average of \$28.00 a year. It was last raised in 1987. It cannot be avoided and goes on your property tax bill. Terry also noted there will be a possible increase due to the city raising their water rates.

Code Enforcement – Don Stifter Stickers are due by end of June. See the "Fossil Footprints" for Don's update. Don will be stepping down as a POAC Rep.

Community Relations – Chuck Van Patter He had not attended any meetings. Wayne mentioned to the City Council that Novy Road needs to be addressed for the erosion so close to Hawk Lake. Shadow Lakes is requesting at least guard rails along the road in that area by the spill way.

Weed tracking - Bill and Don – There are no chemicals into Hawk Lake, just the weed boat? Yes.

Rep Sue Knuth from FV – Boats and golf carts DO NEED stickers. There was a dock with a boat attached floating down the lake and without numbers it could not be identified. Too many speeders. We have children, walkers. Pay attention to the speed limit.

Rep Marcia Baumgartner from FV – Aerobics will start as soon as the pool opens. 9 to 10 am. M-W-F each week. We will start craft meetings in the pavilion. If anyone has a craft to show, call Marcia. At 2 pm a memorial will be held for Gray (a lady that passed away). We will start orientation with new homeowners with dos and don'ts and answer questions.

Volunteers are really needed for activities, for gates.

Rep Greg Cholek from LHC – Recommendations were given on controls of the water/weeds by Rollins Chemicals. Greg had a proposal list he went over. (Will ask for a copy to attach to minutes). Wayne Kancler responded back to Greg on the issue.

<u>Community Garden</u> is tabled for right now. Will look into next year. Not sure of the location and close to water use.

<u>Phone idea with the gate cards</u>. The office is still getting quotes on that. There are lot of things that go into that. It would be like opening the gate with a code.

<u>Cameras</u> will be going in at the gates and dumpsters. If a homeowner sees something that is not right, contact the office. There are items that are not supposed to go into the dumpsters.

The Shadow Lakes Directory. The Board does not support this idea.

<u>COMMENTS:</u> There is a drainage problem in some areas. A trailer needed to be moved. Construction with yellow permits in the window. Loud music going with golf carts and carts that have no numbers or stickers. There will be a "Meet the Candidates" for the election.
