MAINTENANCE/ARCHITECTURE

Hello Everyone,

With Summer around the corner, the maintenance department has been busy getting our community property in shape. The sports complex area is getting a small face lift. We sealed the basketball court and will be striping it for pickleball as well. The shuffle court has been painted; volleyball and horseshoe areas have been cleaned. The pool was cleaned, repaired and painted. The pool has been filled and tested and is ready to enjoy!

The deck at the Amenity center has been completed and looks great! The shoreline has been cleared by the deck and a bench has been installed in the grassy area to enjoy the view.

Road paving has been completed for the year. Maintenance will be looking into filling potholes later into June. Water turn-on has been completed.

Beach area: Bacteria Treatment Injection- This was a specialized bacterial treatment designed to reduce organic muck, lower phosphorus levels, limit E. coli presence, enhance nitrogen and promote oxygenation. We will monitor its effectiveness for future treatments.

The chemical muck and weed treatment were applied to the fingers in FC, Tully, the channel between TMV/FV and the channel in FV. We will also be running our weed boat in areas that require more attention.

Huge thanks go out to our maintenance crew for helping to clean up and clear the roads and trail after the recent storm. I would also like to thank the people that came out to assist in clearing the debris and assisting their neighbors. We really do have great people here!

If the tree on your property had branches that fell, you are responsible for cleaning this debris. Please take this to the burn area by the Maintenance garage. There is no pickup service. As you can see from the damage that was caused by the wind, if you have a tree on your lot that appears dead or dying, please have it maintained or removed before it can cause damage to you or your neighbor's.

Some projects will require a permit from the city of Braidwood along with a Shadow Lakes permit.

Manager Report, June 2025

This year has brought many improvements to the community. The Board has worked hard to ensure that the yearly budget includes improvements for the Community while ensuring the budget is adhered to. Code Enforcement and Management are committed to beautification of the community by making certain the Property Owners Guidebook is complied with. Warning letters for property upkeep continue to be processed. When an Owner receives a warning letter, note that it is not a fine. It is a courtesy in providing heads up to owners so that a fine is not imposed. Should the warning be ignored, a fine will follow with time to comply or appeal. Keeping properties and buildings clean, painted, and free of trash and debris will assist in avoiding fines. As well as adding value to the homes and property in Shadow Lakes. Vehicles with B plates may not be parked on Shadow Lakes II properties, not private driveways, and not common areas. Parking B plate vehicles, service trucks and the like are subject to fines and tows at the owner's expense.

A few important things to remember:

Be sure to purchase your boat and golf cart decals by July 1st. When purchasing your decals, remember to update your liability insurance with the office. Decals cannot be purchased without an updated record of insurance for each property.

Remember: The Association is not affiliated with Facebook, any postings regarding the Association are not officially put out by Management or the Board of Directors. If you have questions or concerns. Please call or email the office to receive the correct and proper answer on any Association business. All complaints should be routed through the management office; we will do our best to resolve the issue or provide clear answers to concerns.

Assessments must be paid in full to avoid legal collection action by June 15th. Unless you have signed a payment agreement with management.

Building Permits must be obtained for all construction over \$300. It is important to remember that an application with the management office must be completed and approved before obtaining a permit from the City of Braidwood. Braidwood will turn you away if you do not have an approval from the Association to move forward with your project. Keep in mind that all projects have a restrictive time frame in which to complete your project. Please check with the office for specific project timeframes.

TREASURER'S REPORT

The Association's financial position remains strong, and we expect to receive the completed Audit Report from our CPA firm in the next week or so. The full and complete report, when received, will be available in the office.

We are well in line with our 2025 Budget with a few line item exceptions; Administrative Wages, due to multiple software changes, and Water System R&M due to multiple weather related water main breaks.

The Budget Committee will begin working on the budget for 2026 in the next few weeks. We know that we again have a 4% increase from the City of Braidwood for sewer and water, which is approximately 40% of our budget. The Committee will work diligently to keep an increase in dues to a minimum while ensuring we are maintaining and replacing our aging infrastructure. I look forward to working with the new POAC Chairperson, Mary Landolina and her team.
